STEP 1: ASSESSMENT OF CURRENT LICENSING MODEL				
	0	Determine whether your organization currently operates under a perpetual licensing model with VMware.		
STE	P 2:	UNDERSTANDING TRANSITION TO SUBSCRIPTION MODEL		
	0	Recognize the shift from perpetual licensing to subscription-based licensing enforced by Broadcom.		
	0	Understand the implications of moving from owning licenses to paying monthly for product usage.		
STEP 3: FAMILIARIZATION WITH PRODUCT BUNDLES				
	0	Familiarize yourself with the bundled offerings, such as VMware Cloud Foundation (VCF) and VMware vSphere Foundation (VVF).		
	0	Understand that add-on services are available for both bundles on an a-la-carte basis.		
STEP 4: AWARENESS OF DIVESTURES				
	0	Take note of the announced divestitures, particularly regarding VMware Horizon (VDI) and Carbon Black (Endpoint Detection & Response).		
STEP 5: SHORT-TERM IMPACT ASSESSMEN				
	0	If using EoA products that are not up for renewal yet, understand that immediate action may not be necessary.		
	0	Know that support will continue throughout the duration of the current contract.		
		Prepare to discuss future license requirements with your VMware		

partner during renewal.

STEP 6: EVALUATION OF LONG-TERM IMPACT

U	Recognize that most products will no longer be available as
	standalone SKUs and must be purchased through subscription
	bundles.
0	Anticipate the increased costs associated with VMware workloads on-premises and in VMware-powered clouds.

STEP 7: EXPLORATION OF OPTIONS

Consider purchasing a VMware subscription bundle from a reseller
and incorporating the new costs into the operating budget.
Evaluate VMware Cloud Service Providers (CSPs) where licensing
is included in the Infrastructure as a Service (laaS) subscription.
Assess the feasibility of migrating away from VMware to
alternative solutions such as KVM, OpenStack, Nutanix AHV,
Microsoft Hyper-V. Citrix, or Oracle.
